The Ministry of Foreign Affairs presents its compliments to the Embassy of the United States of America, and, with reference to the Ministry's Note Verbale, ~~Pol-keku~~ No. 295, dated September 2, 1968, concerning the Okinawa Satellite Tracking Station of the National Space Development Center of the Science and Technology Agency, and the Embassy's Note Verbale No. 1261, of the same date, in reply to the foregoing, has the honor to inform the Embassy the following: In accordance with the Space Development Corporation Law (Law No. 50 of 1969), which was promulgated on June 23, 1969, the rights and obligations of the State concerning the (specific) functions of the National Space Development Center, which is an organ attached to the Science and Technology Agency, are to be taken over by the Space Development Corporation at the time of the establishment of the said Corporation on October 1, 1969. Consequently, the status of the Okinawa Satellite Tracking Station will be changed to that of a branch office of the Space Development Corporation. However, the said Tracking Station will continue to be placed under the supervision of the Government of Japan in accordance with the provisions of the Article 36 of the above-mentioned

above-mentioned Law, and its work will not change at all.

The Ministry of Foreign Affairs has further the honor to request the Embassy of the United States of America to confirm that, in view of the foregoing, the Government of the United States of America does not have any objection to applying, with the following modifications, the points of agreement between the Government of Japan and the Government of the United States of America concerning the Okinawa Satellite Tracking Station, set forth in the above-mentioned Notes Verbales, to the Okinawa Satellite Tracking Station, in its status as a branch office of the Space Development Corporation, on and after October 1, 1969:
