Dear Member:

On July 8 we sent you an official form compiled by the Government of Japan and the American Embassy in Tokyo.

Apparently question III on Form A is causing some difficulties, which may be cleared up upon examination of the enclosed copy of Ordinance #11, Article 2. If you are not required to have a foreign investment license by reason of being excluded under Article 2, simply indicate the paragraph identification (a through k) which applies in your case.

Note that Form A and Form B are both required of all respondents.

We are anxious to hold the second Business Advisory Group (BAG) meeting. Since the first meeting on June 11, Minister Sneider has discussed our Position Paper with the Japanese Government, and while there has not yet been any reaction, it is known that the Japanese are anxious to receive the questionnaire so that they can better understand our problems. Remember that you will be in a "new country" after Reversion. Get off on the right foot by supplying the relatively limited amount of information that has been requested.

As of this mailing, only 34 out of a total of 108 forms have been received. To emphasize the urgency and importance of this matter, this letter is signed by all of the ex-Chamber Presidents remaining on the island, as well as by President Shipley.

SUBJECT: Survey of Non-Ryukyuan Business Firms

1. Attached is the second group of 54 completed questionnaires and a listing of the firms by name. My records show that this group brings to 87 the number of questionnaires delivered to date to the GOJ Element. Please inform me if your record of "forms received" agrees with this total.
2. Also attached are the following:
 - 2.1 Check list dated 25 August for the US Chamber of Commerce distribution of the questionnaire.
 - 2.2 Member roster of the US Chamber of Commerce.
 - 2.3 Check list dated 25 August for USCAR's distribution of the questionnaire.
 - 2.4 Additional list of firms to which USCAR sent copies of the forms but which were not completed. We have found in our distribution that these firms could not be located, had merged with other firms, or had terminated business operations in the Ryukyus. For whatever reason, these are firms "of record" for which we apparently should not expect to receive a reply.
3. When a sufficiently large additional group of completed forms has been received, I will forward it to you for transmission to Tokyo, along with copies of an updated "check list" for both the Chamber and USCAR distributions. I am forwarding the second copy of the completed forms to our Embassy in Tokyo.
