

SUBJECT: Survey of Non-Ryukyuan Business Firms

1. Attached is the third group of 77 completed questionnaires and a listing of the firms by name. My records show that this group brings to 164 the number of questionnaires delivered to date to the GOJ Element.
2. Also attached are the following:
 - 2.1 Check list dated 16 September for the U S Chamber of Commerce distribution of the questionnaire.
 - 2.2 Supplementary list of Chamber of Commerce firms which were deleted from the original listing. The reason for each deletion is noted on this supplementary listing.
 - 2.3 Check list dated 16 September for USCAR's distribution of the questionnaire.
 - 2.4 Supplementary lists of USCAR's addressees which were deleted from the original listing. The first list is comprised of those addressees which never received the questionnaire; the forms were returned by the post office when the addressee could not be located. The second list consists of addressees to which the post office apparently delivered the questionnaire. However, the firms could not be contacted subsequently by mail or telephone. We assume that the firms listed on both lists are no longer in business on Okinawa.
 - 2.5 Questionnaire status sheet presenting a summary explanation of the entire survey.
 - 2.6 Addenda to the originally submitted forms of Smyth Van of Okinawa and Far East Marketing Agency.
3. The questionnaire of Ryukyu Manufacturers & Distributors is incomplete for reasons noted on the form. As soon as the required additional information is received, it will be forwarded to you.
4. Included with this transmission are the forms submitted by Bank of America and American Express, which were sent the special survey for banking institutions.

5. With the inclusion of this group of questionnaires, you should have received replies for approximately 71.2 percent of the non-Ryukyuan businesses to which the form was sent. As indicated in the distribution lists, some further responses can be expected. However, I think the response to date in excess of 70 percent is quite surprising. It should provide an adequate basis for the GOJ to form an evaluation of non-Ryukyuan business activity on Okinawa. I hope we can realistically expect that the individual firms will begin to receive replies from the GOJ on their specific problems in the next 2-3 weeks, as you suggested earlier might be the case.

6. I am forwarding the second copy of completed forms to our Embassy in Tokyo.
