4. 日本政府の意見の取扱いについては、必要に応じてしかるべき場(追って決める)において日琉間で協議する。

(注) なお、前記を踏めるに当り、沖縄復帰対策各省庁担当官会議産業経済部会は随時報

告を受けることとし、また日本政府意見は、  
琉球政府より申請書写しを受領した後、原  
則として1カ月以内にとりまとめる方針と  
する。
