



SECTION I

- REGULATION OF COMMUNICATING INFORMATION OR DATA BODIES IN THE JEW
GENERAL SECRETARIAT
LEGAL AFFAIRS DEPARTMENT 1. Organization or
structure and the scope of this regulation for bodies taken or
1. The Legal Affairs Department is hereby reorganized to include
the former Judicial Department and Land Tribunal and is assigned the
following mission, functions and responsibilities.
2. **MISSION**
a. To advise and assist the high commissioner and the civil
administrator, the Government of the Ryukyu Islands and other public
agencies and private institutions in the Ryukyu Islands concerning the
development and application of sound legal and legislative policies and
procedures.
b. To prepare legal opinions and legal documents as required
and to provide legal guidance and assistance to the high commissioner,
civil administrator and other USCAR departments.
c. To draft and review proclamations, ordinances and pro-
posed legislation of the Government of the Ryukyu Islands dealing with
all governmental, political, economic, social, public health, labor, and
criminal matters as well as those necessary to accomplish the specific
objectives of the civil administration such as the legislative documents
necessary to acquire land for military use and those required or advis-
able to establish and maintain a military base.
d. To represent the United States in litigation before USCAR
Courts of original jurisdiction and in the USCAR Appellate Court.
e. To provide guidance, direction and assistance to the Legal
Affairs Department and Procurator of the Government of the Ryukyu
Islands.
f. To perform all other legal and legislative actions neces-
sary or desirable to the civil affairs objectives of the United States.
g. To advise and assist the high commissioner and the civil
administrator, all United States services and agencies in the Ryukyu
Islands and the Government of the Ryukyu Islands in the formulation

responsible and the coordination of the general programs in the execution

(3) To locate and negotiate with counterparts to the effect
and implementation of policies, plans and procedures relative to the
United States Land Program.

h. To prepare and coordinate with the appropriate agencies
drafts of proposed proclamations, ordinances and directives designed
to accomplish the above.

i. To perform all other actions necessary or desirable to
establish and conduct the United States Land Program in the Ryukyu
Islands.

j. To take custody of and administer all Japanese State and
Prefectural owned properties throughout the Ryukyu Islands.
k. To advise and assist the high commissioner, the civil
administrator, and the Government of the Ryukyu Islands in the formu-
lation and implementation of policies, plans and programs relative to
the establishment and maintenance of judicial structure based upon
sound principles and procedures of democratic government; to exercise
advisory supervision over the local courts of the Government of the
Ryukyu Islands; to promote and encourage high standards of profes-
sional ability and legal ethics among practicing Ryukyuattorneys and
judicial officials; to establish and operate a system of United States
Civil Administration Courts in accordance with Executive Order 10713,
dated 5 June 1957, as amended.

l. The mission of the United States Land Tribunal for the
Ryukyu Islands is to hear and determine:

(1) All matters concerning land and real property con-
demnation in the Ryukyu Islands by any agency of the United States
Government.

(2) All factual and legal issues pertaining to compen-
sability and the extent of just compensation for property taken or
damages claimed either under Declarations of Taking, Certificates of
Affirmation or commonly accepted principles of due process in the law
of eminent domain.

(3) Questions involving interpretations and implementa-
tions of HICOM Ordinance Number 19 and other laws and ordinances
pertaining to United States land acquisition; the meaning and extent of
any estate in land acquired by the United States and procedural conformity
with condemnation procedures; operation of the Ryukyu Government
and its functions and responsibilities before and thereafter.

(4) All other matters and issues pertinent to the deter-
mination of any of the above or necessary to complete action by the
Tribunal or to enforce its determinations and orders provided, however,
that (a) any case within subparagraph (2) above which is more properly
for settlement under United States forces' claims procedures shall be
determined under said claims procedures, and (b) nothing herein shall
be construed as authority for the Tribunal to inquire into the wisdom of
the governmental use to which any condemned land has been or will be
devoted.

FUNCTIONS AND RESPONSIBILITIES

Draft, coordinate and promulgate proclamations, ordi-
nances, directives and instructions necessary to promote establishment
of democratic procedures in the Ryukyu Islands and furnish guidance to
insure conformity with United States policies.

b. Propose, draft, and coordinate proclamations, ordinances
and other legislation for issuance by the high commissioner or the civil
administrator and review legislation proposed by other USCAR depart-
ments and the Government of the Ryukyu Islands to determine legal suffi-
ciency and conformity with command policies.

c. Render legal opinions and provide legal advice to the high
commissioner, the civil administrator, other USCAR departments and
the Government of the Ryukyu Islands on all civil affairs and Ryukyu
matters.

d. Investigate, prepare for trial and prosecute criminal
cases before USCAR courts and represent the United States in civil
litigation.

e. Supervise the legal activities of the Government of the
Ryukyu Islands Legal Affairs Department and all activities of the

Executive Order of the High Commissioner for the Ryukyu Islands concerning the trial by USCAR Criminal and Civil Courts, after determining the propriety of such reference; advise the Procurators concerning prosecutions in Government of the Ryukyu Islands courts; maintain study concerning law interpretation and enforcement in all courts and make recommendations for improvement in all legal substantive, procedural, and administrative fields; advise civil and military law enforcement agencies concerning all of the above; propose and draft necessary USCAR and Government of the Ryukyu Islands legislation in all of said fields and coordinate as necessary with military, judicial, and law enforcement agencies.

(e) VII. Legal: (i) Maintain constant review of Government of the Ryukyu Islands and USCAR legislation with a view to rescinding the latter upon adequate assumption or responsibility by Government of the Ryukyu Islands in its development as an autonomous local government; review for legal sufficiency, adequacy and conformity with command policies; proposed legislation to be submitted to, and that enacted by, Government of the Ryukyu Islands Legislature; oversee preparation of democratic procedures to the Ryukyu Islands and return to the Ryukyu Islands of all powers and functions. (ii) Maintain supervision over all Government of the Ryukyu Islands and U.S. governmental operations in the Ryukyus with view of safeguarding civil rights, observance of due process of law and other requirements of U.S. policy.

(f) VII. Legal: (i) Establish and maintain high standards of legal ethics and professional ability among members of the Ryukyuans bar and judicial officials; supervise the Ryukyuans Bar Association; propose and determine rules and regulations for the Ryukyuans Bar Association; maintain law library, including available Ryukyuans and Japanese laws; encourage codification of laws and adequate translation thereof into English; perform all other functions expected of the civil affairs law office. (ii) VII. Legal: (ii) Develop and implement policies, plans and procedures designed to accomplish the broad objectives of the high commissioner and the civil administrator on matters relative to the United States Land Program in coordination with United States services and agencies and the Government of the Ryukyu Islands.

Executive Order of the High Commissioner for the Ryukyu Islands concerning the relocation of families required to be removed from United States held areas through coordination with the service or agency requiring use of the land, local government officials and the individuals concerned; arrange for procurement and preparation of a suitable relocation site; provide such salvage materials as can be obtained to assist reconstruction; supervise actual movement and coordinate the payment of resettlement funds.

(h) VII. Legal: (i) Plan the relocation of families required to be removed from United States held areas through coordination with the service or agency requiring use of the land, local government officials and the individuals concerned; arrange for procurement and preparation of a suitable relocation site; provide such salvage materials as can be obtained to assist reconstruction; supervise actual movement and coordinate the payment of resettlement funds.

1. Obtain permits for the conduct of surveys for land where acquisition is contemplated; to assure minimum amount of acquisition and elimination of all possible dwellings or other structures and arable land along with proper boundary adjustments; obtain permits from municipal officials to conduct training exercises in areas not held under leasehold by the United States; serve advance notification of use of training areas, maintain records of such use and assist in obtaining compensation therefor and in handling damage claims.

2. Investigate, recommend and coordinate the release of U.S. held areas no longer required.

3. Assist in the settlement of restoration responsibilities of land released by converting the land to its previous condition or payment of damages in lieu thereof.

4. Seek out, investigate, and take custody of all properties of the Japanese Government and the former Okinawa Prefecture throughout the Ryukyu Islands; after investigation allocate the use of land and properties so owned to the United States and the Government of the Ryukyu Islands as required; lease remaining areas to enhance the economy, and dispose of lands, timber and sands, as authorized.

5. Investigate and recommend the issuance of prospecting and mining rights in coordination with the Government of the Ryukyu Islands and interested USCAR departments to permit the location and exploitation of mineral deposits.

6. Advisory supervision over the local Ryukyuans courts, rendering guidance for the administration of justice in accordance with democratic principles.

The establishment and operation of a system of United States Civil Administration Courts in accordance with Executive Order 10713.

(1) Civil Court Jurisdiction.

(a) Cases affecting the security, property, or other interests of the United States as determined by the high commissioner.

(b) Cases in which a member of the United States Forces or the civilian component thereof, an employee of the United States Government who is a United States National, or a non-Ryukyuans dependent of the foregoing, is a party.

(2) Criminal Court Jurisdiction.

(a) Cases involving United States Nationals employed by the United States or any agency thereof who are not subject to trial by courts martial under the Uniform Code of Military Justice, and their dependents, excluding Ryukyuans.

(b) Cases affecting the security, property, or interests of the United States as determined by the high commissioner.

(c) Cases involving persons subject to trial by Courts Martial under the Uniform Code of Military Justice, when the military commander determines not to exercise military jurisdiction and indicates to the high commission his approval of referring the case to another court.

(3) Appellate Court - Appellate Jurisdiction.

(a) All cases tried in the civil administration inferior courts, both civil and criminal.

(b) Any case decided by the highest court of the proposed Government of the Ryukyu Islands, which involved a conflict of decision between said court and the highest appellate court of the civil administration; or a question of United States, foreign, or international law, including the interpretation of any treaty, Act of Congress of the United States, Executive Order of the President of the United States, or proclamation, ordinance, or order of the high commissioner.

s. The United States Land Tribunal is to conduct hearings, take appropriate testimony and evidence, subpoena witnesses, books, records, and documents, and otherwise perform a quasi-judicial body. The Tribunal shall adopt such rules of procedure and practice as it deems necessary to effect orderly and just administration, shall cause such rules to be made available to all interested persons, and shall keep such files and records as may be necessary for public and permanent record of its proceedings and actions and shall be provided with adequate facilities for performance of its functions.
